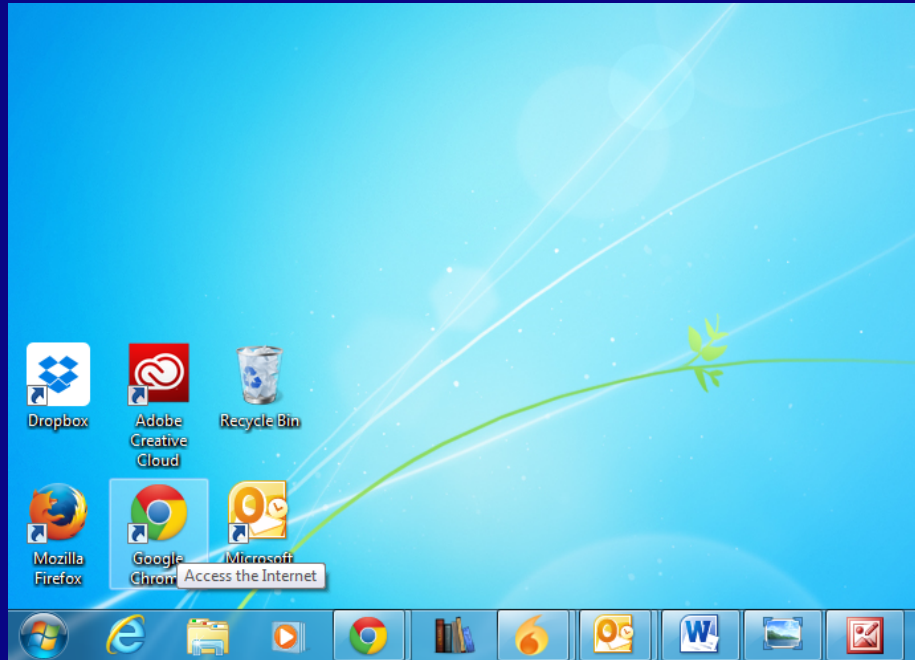

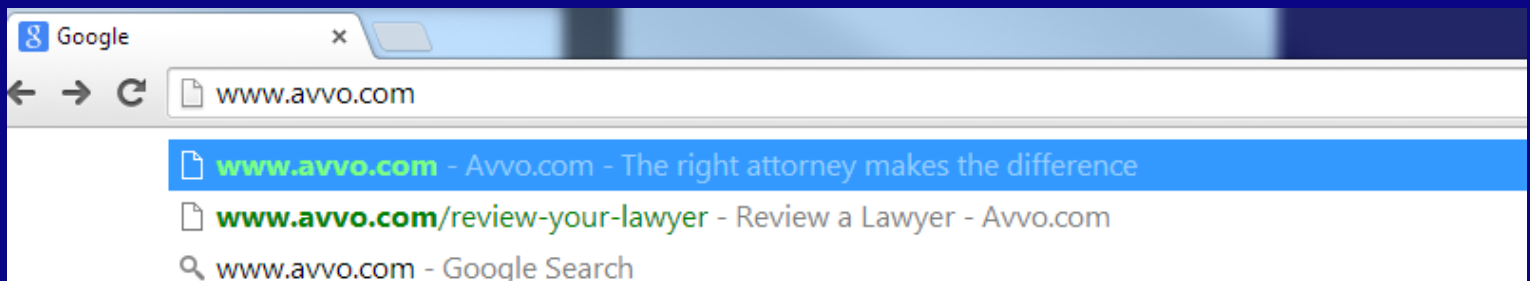

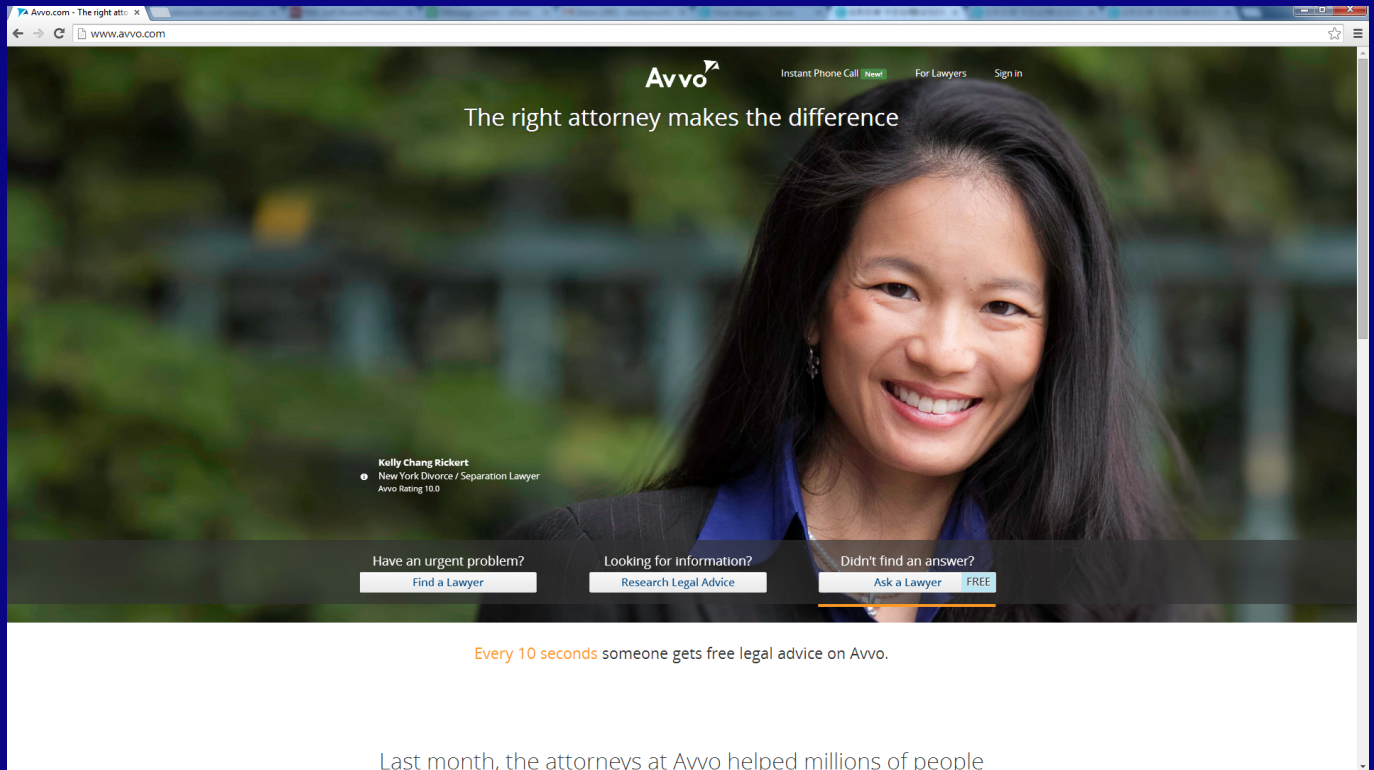
STEP 1: Click on your preferred web browser to begin creating your account.



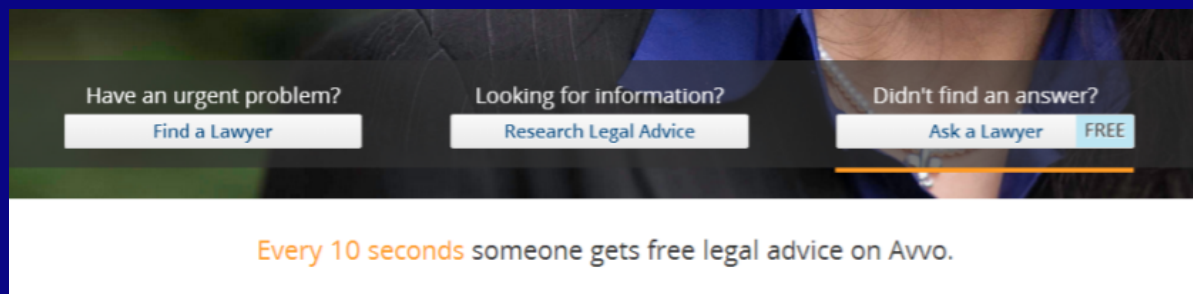
STEP 2: Type in the web address for Avvo.

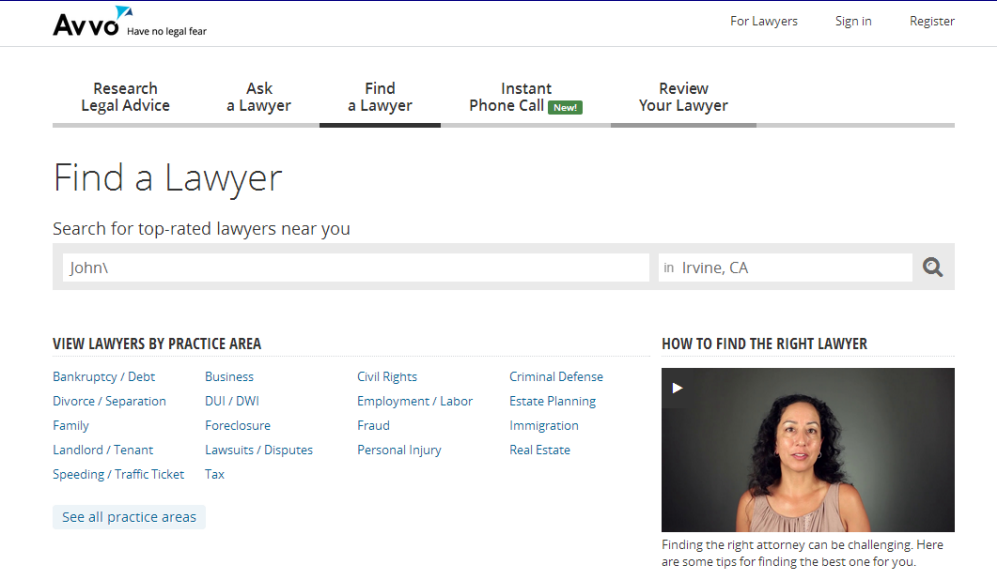


STEP 3: You will now see this screen.



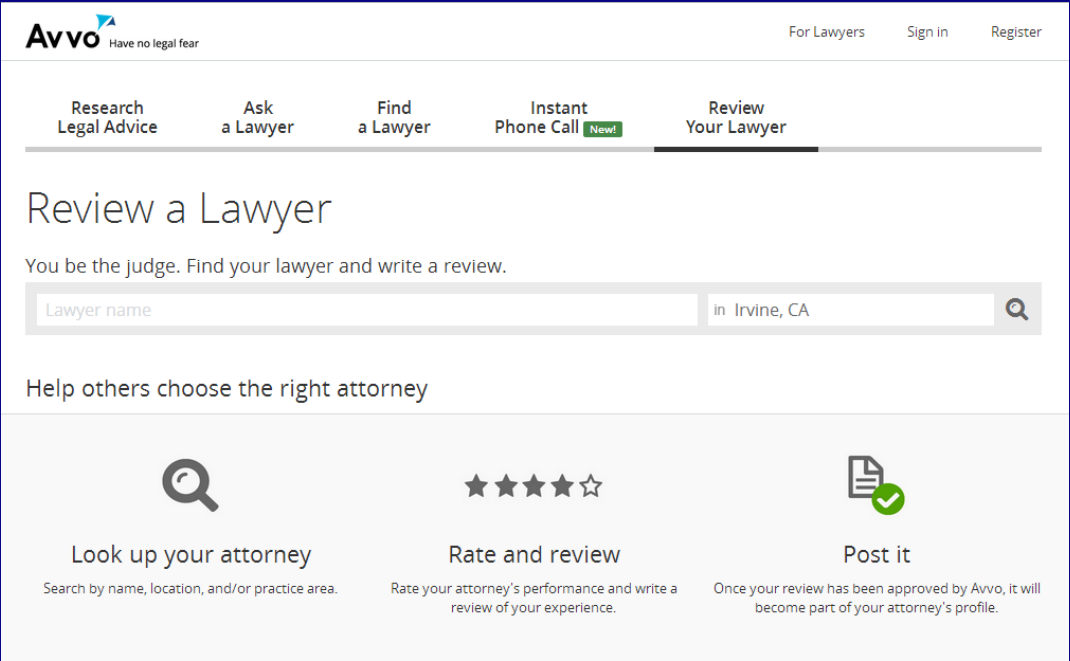
STEP 4: Click on the box that says "Find a Lawyer."
